**All equipment must be returned the day after your first playoff game loss or a \$250.00 late return fee will be charged and will not be permitted to play the following year.** Football practices begin the last Monday in July and will be 3-5 nights per week. All football practices after Labor Day will be a maximum of 3 nights per week. Cheer practices will be 2-4 nights per week. However, ALL practices will be determined by the head coach or squad advisor. All games are held on Saturdays; however, some clubs require Sunday games. Game dates/times will be determined once the schedule is released in August. This is a travel league. All program participants will be required to provide their own transportation to and from practices and games. **\*\*All Physicals must have a 2015 Exam Date on them.**
